2. The said Augustus Van Zant (1828-1884) was the son of John Van Zant, born June 10, 1791; died 1881, and his wife Ann Voorhees, born September 28, 1797; died June 16, 1881; married November 20, 1817.

3. The said Ann Voorhees was the daughter of Stephen Voorhees, born February 21, 1771; died December 11, 1851, and his wife Sarah Hageman, born September 28, 1775; died April 15, 1857.

4. The said Stephen Voorhees (1771-1851) was the son of Gerrit Voorhees, born March 15, 1739; died November 16, 1816, and his wife Ann Beekman, died December 26, 1825.

5. The said Gerrit Voorhees (1739-1816) was the son of Coerte Gerritse Van Voorhees, died 1750, and his wife Neeltje Hageman; married April 13, 1716.

6. The said Coerte Gerritse Van Voorhees was the son of Gerrit Coert Van Voorhees, and his wife Willemetje Peters, died 1744; married April 26, 1685.

7. The said Gerrit Coert Van Voorhees was the son of Coerte Stevens Van Voorhees, born 1737, died 1792, and his wife Marretje Gerritse Van Couwenhoven, born 1644, died between 1702/9; married prior to 1664.

8. The said Coerte Stevens Van Voorhees was the son of Stevens Coerte Van Voorhees, born 1600, died 1684.
